Introduction

Steeple Bumpstead Parish Council has produced and submitted a Neighbourhood Plan for the parish (under Regulation 15) to Braintree District Council, along with 5 supporting documents. Braintree District Council is responsible for all the remaining stages of making the Neighbourhood Plan.

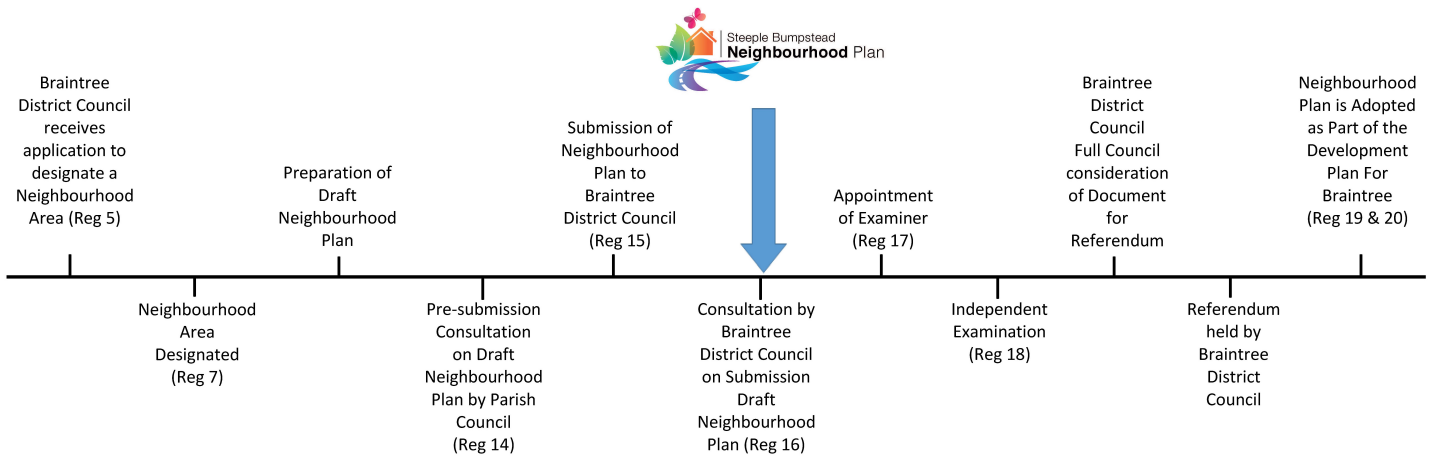
